### **Jim McCarter, Auditor General of Ontario**

Jim McCarter was appointed the Auditor General of Ontario by Ontario's Legislative Assembly in December 2004. Before his appointment, Jim was the Provincial Auditor since the retirement of former Provincial Auditor Erik Peters on September 30, 2003.

Prior to assuming these responsibilities, Jim spent almost four years as Ontario's Assistant Provincial Auditor. Before that, he was the Government of Ontario's first Assistant Deputy Minister and Chief Internal Auditor. In this role, Jim's primary responsibility was to lead a restructuring of internal audit across the Ontario government to enable it to provide more integrated, streamlined, and customer-focused professional audit services.

Prior to serving as the government's Chief Internal Auditor, Jim was an Executive Director in the Office of the Provincial Auditor of Ontario. In 1989-1990, Jim served as Auditor General of St. Kitts and Nevis in the Caribbean on behalf of the Canadian International Development Agency.

Jim is a chartered accountant. He also has an MBA degree from York University and a Certified Information Systems Auditor designation.
